## HVGC PRIVACY STATEMENT

HVGC holds the data you have given us on your membership form in order to maintain your handicap and membership status, as well as to fulfil our constitutional duties with respect to informing you of certain club requirements and activities.

Your name and gender data is used for maintenance of your handicap. This data is passed to England Golf by Club Systems International (our handicap software provider) for maintenance of the CDH database. Your data is not passed to any other organisation or person outside the club.

Your telephone number and email address are used to contact you for competition and other club activity arrangements.

Data is retained on an annual basis as required for administration purposes and then archived for historical purposes.

You are entitled to ask us for details of the data we hold on you, and we are required to provide you with the information within one month. . Please address your request to the Club Secretary.

## **Payment of Subscriptions.**

The subscription required by Horsehay Village Golf Club is £30 plus affiliation fees to County and National bodies. The total amount payable depends upon your status, ie. Adult or Junior & Male or Female (different affiliation fees), and also the time of year when you join.

Annual subscriptions are due from 1<sup>st</sup> January and are :

Adults(Gents) £48.60

Adults(Ladies) £49.00

Junior Boys (under 18 as of 1 <sup>st</sup> January 2019)	£35.60
Junior Girls (under 18 as of 1 <sup>st</sup> January 2019)	£29.00
Junior Boys & Girls, if under 12 as of 1 <sup>st</sup> January 2019	£20
Social members	£10

If you are a member of another golf club & wish to join us as an away member then the fees are;

Ladies & Gents, £30 from 1<sup>st</sup> January and £20 from 1<sup>st</sup> September. However if your home club is outside of Shropshire & Herefordshire then the fee is £39.60 for gents, £40 for ladies or £20 from 1<sup>st</sup> September.

Anyone wishing to join between 1<sup>st</sup> January and 31<sup>st</sup> August must pay the annual subscription.

Adults joining between 1<sup>st</sup> September and 31<sup>st</sup> December pay £20 in the first year.

The Junior subscription is £10.00 after the 1<sup>st</sup> September in the first year.
